Application Intake

In 2016, the BC Provincial Nominee Program (BC PNP) received 5,363 applications: 5,282 Skills Immigration (SI) applications (98.5 per cent) and 81 Entrepreneur Immigration¹ (EI) applications (1.5 per cent).

This compares to 2015², when the program received 3,753 applications: 3,575 SI applications (95.3 per cent), and 178 EI applications (4.7 per cent).

Highlights

The category breakdown is in Table 1. Express Entry BC (EEBC) application intake accounted for 45.1 per cent of applications received in 2016, an increase from 34.9 per cent in 2015.

The Skilled Worker and EEBC – Skilled Worker categories, combined, accounted for 27.1 per cent of applications received in 2016. This compares to 46.1 per cent in 2015. International Graduate and EEBC – International Graduate categories, combined, increased to 39.9 per cent in 2016 from 27.4 per cent in 2015.

Registration Intake

Skills Immigration

Registration is required for all SI categories, except Healthcare Professional, EEBC – Healthcare Professional, International Post-Graduate and EEBC – International Post-Graduate. There is no fee for SI registrations, and once registered, it is immediately placed in the SI pool of registrants, from which invitations to apply are issued.

Highlights

In 2016, SI received nearly 13,000 registrations. The International Graduate and EEBC – International Graduate categories accounted for 47.2 per cent of registrations received.

2016 is the only full year with registration intake.

Entrepreneur Immigration

Registration is required for EI categories and there is a \$300 fee. After the registration is received, it is assessed to determine if it qualifies for entry into the EI pool of registrants, from which invitations to apply are issued.

In 2016, EI received 503 registrations. Of these, 383 were qualified registrations.

Nominations

The BC PNP was initially allocated 5,800 nominations from Immigration, Refugees and Citizenship Canada (IRCC) for the calendar year 2016. Late in 2016, a re-allocation of available nominations allowed the BC PNP to nominate 6,004 workers and business owners.

Highlights

In 2016, 46.7 per cent of nominations were from EEBC categories. This is similar to the proportion of EEBC nominations in 2015 (48.8 per cent).

The proportion of Skilled Worker and EEBC – Skilled Worker categories combined was 33.8 per cent in 2016, from 44.6 per cent in 2015.

There was a substantial increase in nominations from the International Graduate and EEBC – International Graduate categories (increased to 37.9 per cent in 2016 from 26.1 per cent in 2015).

Entrepreneur Immigration Work Permits

Applications to EI require an additional step prior to nomination. Provided criteria are met, EI applicants receive a work permit supported by the BC PNP to manage the business being established or bought in B.C.

In 2016, EI approved 113 work permits. This compares to 84 in 2015, a 34.5 per cent increase.

Top Source Countries

The nominee's country of citizenship is used to determine source country. Table 6 presents the top 10 source countries for SI nominations, and Table 4 shows the top 5 source countries for EI nominations².

SI nominations

Largely, the top countries for SI nominations stayed the same from 2015 to 2016. In 2015, Japan and Jamaica were in the top 10 source countries (with 3 per cent and 1 per cent of SI nominations, respectively). These two countries were replaced with Iran and Brazil in 2016.

EI nominations

China continued to be the top source country for EI nominations. In 2016, the top 5 source countries accounted for 84 per cent of EI nominations, where the top 5 in 2015 accounted for 75 per cent.

In 2015, the United Kingdom represented 7 per cent of EI nominations, along with the Netherlands (3 per cent), India and Italy (each with 2 per cent). These were replaced by South Africa, Germany and Vietnam in 2016.

Top Occupations – Skills Immigration

The top 10 occupations for SI nominations³ in 2016 showed a change in nomination composition. Previously, cooks and food counter attendants accounted for 23 per cent of nominations in 2015, but in 2016 this reduced to 10 per cent.


Highlights

Transport truck drivers became the top occupation in 2016. Increases were also seen in managerial and supervisory positions in food service.

There was a marked shift towards technology jobs in 2016, with a jump to 17 per cent of SI nominations 2016 from 10 per cent in 2015.

SI nominees

The city of intended residence (or residential address) is used to determine the SI regional distribution, with the top 5 regional districts shown in table 10.

Greater Vancouver continues to be the primary destination for SI nominees.

The Nanaimo and Fraser Valley regional districts saw increases in EI nominees in 2016, while Greater Vancouver experienced a decrease.

Average Salary

The average salaries for SI nominees⁴ have increased across all categories from 2015 to 2016.

Highlights

Significant increases were notable in the EEBC – Skilled Worker and the Entry Level and Semi-Skilled categories, with nominee wages increasing 28.7 per cent and 46.3 per cent, respectively.

The increase in transport truck drivers in the ELSS category appear to have contributed to the increased wages in that category, and the move from cooks and food service supervisors to more technical positions would drive higher EEBC – Skilled Worker wages.
